Your application was received 02.06.2020 and has been given the reference number 20/00619/HOU. Please accept my sincerest apologies for the delaying in validating your planning application which I am about to begin on.

I am still to validate the plans but I see that there are no fee details linked to the application. Can you confirm if the fee of £206 has been paid by you or your client?

If the fee has been paid can you please advise on what date it was paid so I can locate in our payment system and link to the application.

The Local Planning Authority is dealing with a large backlog of applications received since April. This has been caused by the coronavirus pandemic, staff departures and the ongoing Solent nitrates issue, which prevented most new residential developments being approved.

To remedy this, we have recruited new staff, and outsourced the processing of many applications. Our processes have been changed to support the remote submission, registration and assessment of applications, and 'virtual' planning committees now allow approvals to be granted. It is intended that all of the delayed planning applications will be registered by the end of this year. We will then continue to provide the level of service that meets our own and our customers' expectations.
