.Reason for preposed work - I have carried out a VTA on these tree's in summer and in winter and the vitality of the crown is very poor. There are signs and symptoms of die back within the crown. The owners would like to try and retain what they can of the tree's due to there location within the boundary hedge. Therefore we would like to carry out a reduction of approx 50% of the crown to reduce the risk the tree's pose as the location is a particular windy site.
