Fell/remove the tree because it is situated extremely close to a supporting wall where the ground level drops dramatically on the other side and there is concern that the tree has exceeded the space in which it was planted and will compromise the structural integrity of the supporting wall.

Fell/remove the tree because it is situated so close to the boundary that it has damaged the boundary fence and is preventing a new boundary fence from being erected.

Fell/remove the tree because it is shading the adjacent Yew tree which is considered to be the show piece of the properties front garden
