e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1- fir tree on right of gate facing in. Crown lift of lowest branches closest to neighbouring property as they rub and cause damage to property.

T2- copper beech. 2m reduction of canopy on the side closest to owners house as leaves clog all drains.

T3- yew tree. Reduction to side overhanging the mariners hotel by 3m as branches interfere with property.

T4- sessile oak. Removal of tre on adjacent property as roots are pushing up through foundations and damaging property. Replant with same species nearby.

T4- yew tree. Tree in poor condition and neighbor would like the top lowered to 2m.
