e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Reduce Beech (T1) by roughly 5M in height and 2m width from roadside. Right side has been reduced previously when house was built. Pollard Lime tree (T2) to just above fork drawn in red on photo. Leaving roughly a 25ft stem to allow smaller trees on site to grow up and allow more light into the property. Remove Branch from base of tree marked it blue down to epicormic growth.
