Site workers will not be conscientious to residents and they will cause hold ups, fumes and not to mention the noise that we will incur from the building work, again spoiling the peacefulness and quietness of this small village.

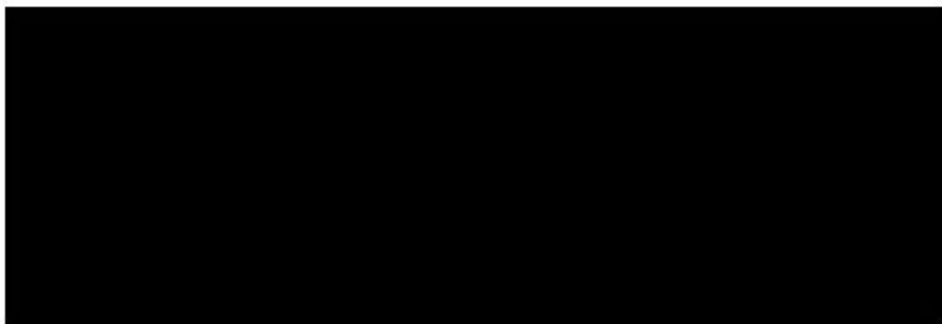
If planning permissions like this have already been objected then why has this even been allowed to be considered again. It is utterly disgraceful.

I strongly oppose to this proposal. Below are the reasons why;

- The proposed site entrance is located on a very narrow country road, which already incurs some back up of traffic at busy times, and will become very dangerous for walkers, children, horses and bikes when lorries and wagons are constantly up and down.
- The narrow country road which will be used for access to the proposed building site is located near a quiet school, this imposes a safety risk to the children, entering and returning from school.

- The entrance to the proposed building site is located opposite our home that has stood here for number of years, this will cause access issues for us and also imposes a safety risk to our children.

- It will affect the beautiful cricket club that we proudly home, and is renowned for its beauty and tranquility.
- I noticed on the plans that there is talk for a possible link road in the future, why turn a quiet and peaceful village into a busy town.
