1 - removal of laburnam tree, self set tree and is surrounded by multiple other mature trees. We have already replaced it with another laburnam in a more suitable place.
2- removal of walnut tree. Firstly it has a small cavity at its base. It was originally planted as an addition to the orchard fruit trees however it has now overtaken the orchard and is affecting the growth of plums and apples. The walnut itself is poor at fruiting.
3-moon rocket. The tree is dying due to age and suppression by surrounding trees.
4- cedar already dead
5- flowering cherry tree, this is dying
