With reference to application 20/01753/out.

We note this is an application for a separate vehicular access to the outline approved building plot on land adjacent to 46 Harwich road. We wish to object to this for the following reasons.

- Attention is drawn to communication from Essex County Council Highways and transportation dated 05/10/20 concerning application <u>20/01038</u>/out.
- 2. As mentioned in this letter there is a tarmac lay-by in front of the property which is used daily as a request stop and by other vehicles as a pull in to seek directions etc. This is a very busy road with ever growing heavier traffic and these lay-bys are of increasing importance.

With regards to the use as a request stop for the local buses which I stress again is in daily use and forms an important link for the local elderly and disabled inhabitants.

I believe it is one of the Councils strongest objectives to promote the use of local transport not to prevent it.


- 3. There seems to be several discrepancies on the plan provided by the applicants.
- A. There is no mention of the second cable vault.
- B. There is no mention of the telegraph pole.
- C. The presence of the tarmac lay-by seems to be completely ignored.
- The application seems to ignore the recommendations of the ECC Highways that the existing drive should be widened to serve both the new and host dwelling.
- 4. The applicants state that the existing drive already has lots of traffic and is increased by the approval of two dwellings at 45 Harwich road. A separate access has been approved for these and there will be no extra traffic on the shared drive which will remain the same as it has for the past years.
- 5. The application has not demonstrated that there is a clear 240m visibility spay from the proposed driveway access.

As can be seen by the photographs recently put up by the application that the lay-by is constantly used. And clearly show the second cable vault.

I would suggest that if this application is approved then all costs as to moving telecommunication cables, relocating the bus stop and changing the tarmac lay-by should be borne by the applicants and not the taxpayer!
