T3- Sycamore.

Crown raise to 6 meters, Reduce in height by 2 meters, reduce remaining canopy by 1 meter.

T4- Sycamore.

Crown raise to 6 meters, Reduce in height by 2 meters, reduce remaining canopy by 1 meter.

T5- Horse Chestnut.

Remove epicormic growth from main stem, crown raise to 6 meters, reduce canopy by 1 meter.
