The Council has received the following planning applications.

21/00049/FULL. Part change of use from retail to residential, x1 new door to the ground floor front elevation, two storey rear extension (first and second floors) with x1 second floor balcony, raising of the central flat roof over the retail area with new roof lanterns, new balcony to the first floor rear elevation, alterations to fenestration, associated residential bin enclosure and bike storage with rear service yard enclosure and x1 parking space and new rear boundary treatment to create x7 flats - 74 High Street, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area)*

20/03433/FULL. Installation of photovoltaic cells to the existing pergola and outbuilding - The Grange, The Street, Waltham St Lawrence, Reading. *(Development Affecting the Character or Appearance of a Conservation Area)*

21/00025/FULL. Single storey rear extension and alterations to first floor fenestration following demolition of existing element, part garage conversion to workshop with associated works to include removal of window to side elevation and boundary treatment to include new pedestrian access - Manor House, New Road, Hurley, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area and Development Affecting a Public Rights of Way)*

Consent to repair and redecoration of the pebbledash render and external joinery including windows and oriel windows, repair to rear steps and paving, replacement of spalled bricks, replacement of rotted external timber including window frames and cills and weatherboarding to oriel windows, repointing to part rear elevation and roof tile repairs - Drakes Hide, Brocas Street, Eton, Windsor. *(Listed Building Consent)*

20/03233/FULL. New entrance gates and panel fencing to the existing access - The Holt, Berries Road, Cookham, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area)*

Single storey side and rear extensions, first floor side and rear extensions and alterations to fenestration, following demolition of the existing single storey side and rear elements - Burchetts Green House, Burchetts Green Road, Burchetts Green, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area and Development Affecting the Setting of a Listed Building)*

21/00028/LBC. Consent for single storey side and rear extensions, first floor side and rear extensions, alterations to fenestration and internal alterations, following demolition of the existing single storey side and rear elements - Burchetts Green House, Burchetts Green Road, Burchetts Green Maidenhead. *(Listed Building Consent)*

21/00041/FULL. New stable building - Brookfield Park Lane, Horton, Slough. *(Major Development and Development Affecting the Setting of a Listed Building)*

20/03431/FULL. Installation of a sheetpiled barrier wall to the perimeter of the eastern wing of the hotel, extension of balconies and associated landscaping and compensatory floodplain storage - MacDonald Compleat Angler, Bisham Road, Bisham, Marlow. *(Development Affecting the Character or Appearance of a Conservation Area and Development Affecting a Public Rights of Way)*

21/00071/FULL. Two storey infill rear extension, x1 roof light to existing conservatory and new front canopy - Wickets, Horton Close, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area)*

20/03544/LBC. Consent for replacement windows and door - Bridge House, Public House, Paley Street, Maidenhead. *(Listed Building Consent)*

20/03359/LBC. Single storey side/rear extension with lean to and stairs, internal alterations to ground and first floor, alteration to fenestration on ground and first floor and new chimney following partial demolition of existing diary and demolition of three storey rear bay and existing rear extension and porch - Cruchfield Manor, Ascot Road, Warfield, Bracknell. *(Listed Building Consent)*

20/03426/FULL. Single storey rear conservatory extension - Lauriston, Derek Road, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area)*

20/03435/FULL. Construction of a four storey north (side) extension and a three storey west and north (rear and side) extension with basement following demolition of existing two storey west (rear) and single storey (north) extensions and addition of 3no.car par spaces. (renewal of permission 17/03224/FULL) - Thames Hotel, Ray Mead Road, Maidenhead. *(Development Affecting the Character or Appearance of a Conservation Area)*

20/03429/FULL. Single storey side/rear extension with lean to and stairs, alteration to fenestration on ground and first floor and new chimney following partial demolition of existing diary and demolition of three storey rear bay and existing rear extension and porch - Cruchfield Manor, Ascot Road, Warfield, Bracknell. *(Development Affecting the Setting of Listed Building)*

20/03328/FULL. Change of use of the squash courts to enable use as a children's activity centre ancillary to the overall hotel conference and events use of the site, including a single storey extension, new plant and bin storage, a new slide tunnel, changes to doors and windows and a new outdoor terrace and refurbishment of the adjacent existing tennis courts, including replacement and new floodlighting along with bollard lighting on an existing pedestrian footpath linking to the bedroom wings - De Vere Beaumont Estate, Burfield Road, Old Windsor, Windsor. *(Development Affecting the Setting of Listed Building)*
