Your Right Of Appeal

If you aggrieved by the Council's decision to refuse consent or grant consent subject to conditions, you can appeal to the Planning Inspectorate via www.gov.uk/appeal-planning-inspectorate or by using a form which you can get from the Planning Inspectorate at Environment Appeals, Room 3H, Hawk Wing, Temple Quay House, 2 The Square, Bristol, BS1 6PN within 28 days from the date you receive this decision. The Planning Inspectorate has a discretion to allow a longer period.

Compensation

If you suffer any loss or damage which is caused or incurred in consequent of this refusal of consent, you are entitled to recover from the Council compensation in respect of such loss or damage. If you wish to make a claim you must do so within 12 months from the date of this decision (or, if you appeal to the Planning Inspectorate, within 12 months from the date of his decision). Claims should be submitted in writing to Chief Executive, City Hall, Beaumont Fee, Lincoln LN1 1DF.
