#### Illustrations of the Route 11.0





#### Implementation and Phasing 12.0

## Implementation

The Enderby Relief Road construction would be undertaken by the promoters, in consultation with Leicestershire County Council as highways authority and Blaby District Council as planning authority. Relocation of the compound would be undertaken jointly with SUEZ and their contractors. The authorities and Environment Agency have been consulted on the road alignment details prior to submission of these applications.

## Programme and Phasing

The construction is likely to take six months from a start on site. The start on site is likely to be some 6 months after planning permission is received to allow for detailed construction design, tender and appointments. Variations to the route of the public rights of way would also need to be determined. The project would be implemented in a single phase.

Implementation of the Traffic Regulation Orders on Warren Park Way would be implemented by Leicestershire County Council as highway authority. The programme is provisional and would be agreed with the highway authority once the planning application is determined and various highways approvals are also determined.

# 13.0 Summary and Conclusions

The Design and Access Statement explains proposals for the Enderby Relief Road, a new public route from Mill Hill at Enderby to Leicester Lane. and relocation of the existing landfill management compound. The route is in 5 main sections. The route combines modifications to the existing junction of Mill Hill and Warren Park Way, utilises existing road at Warren Park Way and then joins to the existing road within the first phase of the Leicester Commercial Park (SES Phase 1) with two sections of new road. The applications are for the central sections of the road linking Warren Park Way to the road in the Leicester Commercial Park.

The impacts of the proposals are insignificant, although some loss of the Fox Covert woodland is required to accommodate the road. This would be compensated for with new planting to the north of the woodlands and better management (including transfer of ownership) of the existing woodlands for its wildlife interest.

Significant benefits arise from construction of the road including delivery of major new employment development on an allocated Local Plan site at Enderby Logistics Hub, potential for employment development in the SES Phase 2, and the relief of Enderby cross roads from through-traffic. The designs have been discussed with Blaby District Council, the County Highways Authority and Environment Agency and the operators of the Enderby Warren Landfill SUEZ. A further application would provide for the relocation of the compound.
