We propose to remove sections of wall either side of the existing inward facing courtyard window and door. One wall was part of an extension post 2000. The other wall is part of an outbuilding of unknown date. The rear of the property where the proposed works are located is not Georgian. The listed status pertains to the Georgian front of the property.
