Thank you for your e-mail, we tried to call this morning to discuss your letter and our application but I believe that you aren't able to call out, so your colleague

Carole suggested we email you with our queries.

You have requested that we provide additional information in the following areas:

- 1. Location plan amendment- we should be able to amend the plan and return this to you, we had misunderstood the requirements.
- 2. Metric scale elevations We are requesting permission to replace our windows and front door to look exactly the same from the highway but improve the energy efficiency of our home. It would seem excessive to have to employ an architect to draw up plans of our house to scale for this. Would detailed photographs highlighting the windows that we intend to replace be satisfactory in addition to the scale drawings of the windows?
- 3. Cross sections- I have attached cross sections of the windows. Could you confirm that these are what you are looking for so that I can send them in to the general planning email address as requested?
- 4. Heritage statement we don't understand why a heritage statement is required to replace the windows. Our house is not listed and there will be no demolition works. The windows will be replaced with windows measured to replicate the originals. There will be no change to the dimensions of the windows and no additional building work will be required. We do not intend to remove any of the brick works etc. When my wife was in contact with Zoe Mair from the Conservation team, she said it was a Householder Planning Application that we needed, not the one referring to demolition.
