Description of existing materials and finishes (optional):	Currently, the walls are a mixture of a soft wood cladding (dark brown) and exposed brickwork (dark brown), although there is a small area which uses white PVC cladding on the first floor.
Description of proposed materials and finishes:	Our proposal is to retain the two distinct areas, replacing the cladding with a low maintenance Hardie Plank (cedar arctic white) and the exposed brickwork with a white render.
