Dear Planning

Thank you for your letter regarding this application.

Firstly, I would like to point out that BS 3998:2010 recommends that when crown reduction is specified the extent of pruning should be given in terms of the end result (crown height / spread or branch length) and not by reference to how much is to be removed. The specifications given for trees T1, T2h & T4 are therefore in accordance with this standard and there should be no need for further clarification. However, further information is given as follows:

- T1 – This pruning will be around 2m (the spread was not recorded during the survey).
- T2h – The existing height, as stated in the report as around 12m, so around 7m is to be removed.
- T3 – There is only one upper stem, the other having been removed previously.
- T4 – The existing crown spread measurements are given in the report. The crown will therefore be reduced by around 4m on the northwest side and 2m on the northeast side.

I trust that this gives you enough information to register the application.
