Silver Birch (T2)- Crown lift to 5.3m over the private road and footpath, crown reduce by 2.5m in height and width, clear small branches around streetlight to maximise efficiency, 2 no. cherry plums (T3) - Reduce crown by 1.5m, thin out epicormic shoots, crossing and rubbing branches by up to 1.5m, 1 no. cherry (T4) - Reduce crown on western side by 1.8m, thin crown of epicormic shoots, rubbing of crossing branches by 1.8m
