Walnut (Junglands regia)- REF1
Silver Birch (Betula pendula)- REF2
Two cherry plums (prunus cerasifera)- REF3
One medium cherry plum " " -REF4

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Walnut (Junglands regia)- REF1.
Deadwood and inspect crown for any disease, dangerous or weak limbs.

Silver Birch (Betula pendula)- REF2
Crown lift to 5.3m over the private road and footpath leading to Rivers Court Residential home to provide adequate and safe passage to lorries and emergency vehicles.
Reduce crown by 2.5m in height and width to allow more stability to the tree.
Clear small branches around streetlight to maximise efficiency .

Two cherry plums (prunus cerasifera)- REF3
Deadwood and inspect for disease. Reduce crown by 1.5m Maximum, think out epicormic shoots, crossing and rubbing branches by upto 1.5 allow energy to be redirected to fruiting branches. This work will not be carried out until late spring/ summer other than removal of deadwood for safety.

One medium cherry (prunus cerasifera) -REF4
Deadwood, Reduce crown on western side by 1.8m to allow space for the bordering mulberry.
Thin crown of epicormic shoots, rubbing or crossing brances by 1.8m
This work, other than deadwood removal, will need to be carried out in late spring/ early summer.
