Minor material revision to an extant permission for Replacement paving in front lightwell, partial infill of front lightwell to link basement and vaults and lowering of basement level by 300mm. Refurbishment of property, new wiring etc.

The Amendment are:

1. Basement Floor - Air conditioning condensers in the lightwell (plus internal units throughout)
2. Basement Floor - lowering of vaults and addition of a new staircase
3. Basement Floor - Kitchen Design Details
4. Ground Floor - No toilet nearby the lift - replaced by wardrobe
5. Second Floor - No toilet by the lift but kitchenette
6. 3F layout, minor changes (new roof light in the lobby, change in the lobby, ensuite access to one bathroom, roof light in the mother's bathroom)
7. LGF to 1F Minor changes the staircase (marble treads and risers with traditional nosing and round bronze finish spindles.
(Alternatively, standard veneer wood treads and risers and square wooden spindles, with bronze effect)
9. Minor variations to the lift type, size, doors, including lift pit. Lift shaft in block instead of stud wall
10. Replacement of existing staircase to the lightwell to accord with Building Regulations
11. Replacing the existing single or double glazing with Pilkington Spacia from Pilkington Heritage Range to mitigate against street noise.
