Reasons for work - English Heritage have carried out regular inspections of the trees on Berwick Ramparts since 2014 as part of their management programme. This work was highlighted in the July 2019 inspection.  
Some work is recommended due to storm damage, some due to safety concerns, some to aid future inspections (removal of epicormic growth) and trees 874 and 875 have been pollarded in the past at the request of adjacent residents.
