3 x Silver birch (T1) on rear boundary - Reduce by approx 2 m and reshape crowns  
2 x Beech (t2+3) - Fell to ground level  
Ash (t4) - Remove limbs growing over garage  
Crab apple in front garden (t5) - reduce and reshape crown
