T1) - To attend to the line of 8 Conifer trees located to the left side the drive.

To climb and dismantle the trees section-section to near ground level, taking extreme care of the surrounding area.

T2) - To attend to the line of Conifer trees located to the far left boundary of the nursery.

To dismantle the line of trees section-section to near ground level; taking care of the surrounding area.

T3) - To attend to the row of Conifer trees located on the far right boundary of the nursery (adjacent the pumping station).

To reduce the height of the line of trees by approximately 50% .
