# **Design: Statement**

#### 1.0 Background

- 1.1 This application is for the demolition and replacement of a demountable unit on the site of Glyncoed Primary School to provide 2 classrooms for year 3 pupils with store rooms, separate IT / electrical switch room, boys and girls toilets, accessible staff toilet and staff kitchen.
- 1.2 The existing unit has failed due to rotten substructure and a replacement unit will be provided in its place. Therefore, no additional pupil numbers are envisaged as part of this application and access to and from the site will remain unchanged. A new link corridor is proposed to connect the main school building with the new unit.

## 3.0 Inclusive Design

- 3.1 The proposed development considers all aspects of inclusive design and enables all abilities to safely enter and exit the building. Both ramp and stairs are included and an accessible WC is provided within the new unit.
- 3.2 An Equality Impact Assessment has been completed by Cardiff Council Education section in accordance with the requirements of Cardiff Council as a service provider and can viewed upon request.

## 4.0 Character

#### 4.1 Site:

The existing demountable unit is located to the north side of the main school building, to the east of the car park. This will be demolished to make space for a new modular unit located roughly 6m further north as shown on AL(0)01.

#### 4.2 Layout & scale:

The demountable unit and auxiliary outdoor spaces have a combined footprint of  $397 \text{ m}^2$ . The building footprint of the new unit and corridor link is  $231\text{m}^2$ . The proposal is designed to be single storey to relate to the existing school's height. A flat roof to the link corridor connects the main school building to the monopitch roof of the replacement unit. The monopitch roof allows for controlled drainage into rain gardens which provide water storage and water quality treatment (separate application made for SAB approval.)

The plan layout allows for 2 new classrooms and storage, a staff kitchen, ICT/ electrical switch room, cleaner's store and 5 x pupil's WCs and a staff accessible WC. These will be accessed via the new corridor link. Fire exits with evacuation chairs are provided from each classroom. A plan layout can be seen on drawing AL(0)06 in this application.

#### 4.3 Appearance:

The visual appearance of the proposed demountable unit is shown on drawing AL(0)07 in this application. The unit will be clad in facing brickwork to match the existing school buildings and the link will be constructed of a low E glass curtain walling system above a low brick wall. Typical elevation shown below.



#### 4.4 Landscaping:

A tree survey has been included as part of this application and recommendations given for small area of root protection where a no dig footpath is to be constructed following the survey's advice. Rain gardens are included in the proposal on the south side which are part of the SUDS plan published for SAB approval. Position of rain gardens shown on AL(0)08.

- 7.3 The 2 no. fire exits from each classroom will be stepped and evacuation chairs provided. The link corridor is a 1:21 max. gradient connecting the main school building to the new modular unit.
