The oak T1 will be reduced back by approximately 2 m depending on suitable growth points leaving a radius on the south east side of 4m
The radius of the sycamore T2 will be reduced by 1m to 4 m radius on the south east side only

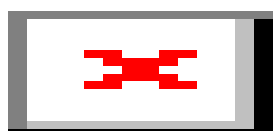

The current height of both trees is 21m and the radius is 6m Oak and 5 m sycamore.
The height is irrelevant as we are not applying to touch the height at all.
For all other authorities I list the finished dimensions normally they are all that are required as the current dimensions of the tree can be seen by the Tree Officer at the site visit .
The specifications are quite self explanatory at that visit .
