Thank you for the consultation on this application.

There are currently no recorded archaeological sites within this development area. There is a recorded Grade II listed milestone on the road verge to the south of the Aberhafesp road and adjacent to Ael y Bryn house and this should be avoided by all proposed access works. The recorded lead mine trial to the east of Ael y Bryn house (PRN 84103) would not be affected. The development site does lie within the Caersws Basin registered landscape of special historic interest (HLW P 5) and the eastern half of the Penbedw historic landscape character area (HLCA 1178). Cadw (cadwplanning@gov.wales) should therefore be consulted to address whether they require a formal ASIDOHL2 assessment of the impact of the development on the registered historic landscape.

The extensive geophysical survey for the adjacent crematorium application has informed this holiday park application in as much as it shows that these sloping fields were not attractive for settlement and have largely been used for post-medieval agriculture after being extensively cleared, drained and enclosed. Narrow late post-medieval agricultural ridges are readily seen across the development area in aerial imagery and there is much evidence of drainage through the use of herringbone drainage systems on the fields immediately south of the holiday park along the access. It is therefore considered that the archaeological potential of the development area is low and that additional geophysical survey of the holiday park field would not yield significant archaeology.

The proposed holiday homes and amenity area are well screened by existing mature hedges and trees, all of which should be retained within the final scheme layout. The site is also screened by local topographic features. The LVIA report does not indicate any significant impacts to the surrounding landscape, or any significant setting impact for the nearby Gwyn Fynydd Camp (SM MG064) scheduled monument to the west.

Pending comments from Cadw on any potential registered historic landscape assessment that may be required, we would have no objection at this stage to the proposed development.
