Permission is kindly sought to re-pollard the home's frontage Weeping Willow tree, as per the same work I applied for on behalf of my client in 2017; consented to by Havant Borough Council; with the work duly carried out on 27/5/17. The tree is about 13.5m tall & 90cm diameter. The maximum diameter of the pruning cuts would be less than 200mm, thus principally cutting off all the epicormic growth, some of which is about 6m long. All such desired work would recreate about 6 significant trunk/branch 'knuckles' again, meaning the tree's branches & foliage wouldn't be within the nearby homes' BT wires still, & the end effect would not be detrimental to the tree's amenity value. Submitted for your consideration please.
