T2 - Low hedge on North East boundary of front garden, remove to allow additional fencing  
T3 - Coppice Bay, Bramble, Holm Oak and Hazel, pollard Holly  
T4 - Lime remove congested epicormic growth around base and third of way up the trunk. Coppice smaller evergreens by Holm Oak.
