T1 - Walnut Tree - 20% Crown Reduction. To reduce shading to and increase light available to residents.

T2 & T3 - 2 x Irish Yew Trees - Remove and grind out remaining stumps. Trees have become unsightly and overgrown they have become an irritant to residents due to excessive shade - electric light required during day in affected rooms. The area is also used for communal activities - the size of the trees has reduced this amenity.

T4 - Holly Tree - Section Fell. The tree is dead.
