T1 Horse Chestnut: Dismantle to ground level.

This tree is causing excessive shading into the neighbouring property. The tree is also close to a wall.

There is a nice copper Beech to the south/east of this tree and a very large mature Horse Chestnut to the north/east. Both of these trees are suppressing this smaller tree between them. A satellite view image shows this clearly. The Copper Beech is a longer term tree that would fill this space over time if left to do so.

Please note this tree has just had a previous application(PP-0938281) to reduce the overhang. The owners have now changed their mind and would like to remove the tree.
