Tree 2 (T2) Sycamore - Showing signs of decay. Straddles fence and concerned it may fall onto house or neighbouring house.

Tree 3 (T3) Spruce - Showing signs of decay, recent large fallen branches and beginning to lean towards house (another large spruce less than 4m).

I am happy to replant with indigenous species in the general vicinity of the ones I am requesting be felled.
