## 5. Description of Proposed Works

Please describe the proposed single-storey rear extension:

A single storey extension on the rear of the property, extending by 3 metres from original external wall to the dining room. This will join on to the small kitchen extension so the length of the new build will be 6.3m. We propose to insert bi-fold doors and velux windows\* in the extended section and remove existing French doors. The kitchen door will be re-located to new external rear wall and a stud wall will be built to create a porch / boot room. There will be a new window facing south in the extended portion.

\* we plan to insert 4 x velux windows in the roof of new extension.
