The condition restricts the benefit of the change of use for the premises to be used as a school, to the school Principal (named as the applicant) as an individual and not the premises, as would normally be the case for a change of use application. The applicant needs the condition to be removed so that the premises can continue to operate as a school when, at some point in the future, Mr Lee is no longer involved. This is also important should the case ever arise where the school is to be operated by a different legal entity.

The school successfully operated, over many years now, across three campuses in both Rutland and South Kesteven. As such, restricting the use of Cross Roads to an individual is really no longer appropriate.

We would request that the condition is removed in its entirety, allowing the operation of the school to continue in perpetuity, irrespective of the proprietor operating the school; and irrespective of the person named as Chair of Proprietors or Principal.
