Thank you for the above consultation regarding the discharge of condition 7 (Photographic Survey) in relation to planning permission 20/0611/FUL at The Birches, Rhos-y-meirch, Knighton.

Consultation of the planning portal shows that a PDF photographic survey report has now been uploaded as part of the application as well as copies of each individual image. This report has been approved, however before the condition can be discharged, and as stated in the original guidance submitted with the condition, the applicant will need to submit a high-resolution copy of the pdf report *and* the original high-resolution images to the Regional Historic Environment Record (HER) at CPAT (e-mail: [gary.duckers@cpat.org.uk](mailto:gary.duckers@cpat.org.uk)) and the National Monuments Record (NMR) in Aberystwyth who are the trusted digital archive for Wales and will ensure long term preservation of the digital record (e-mail: [nmr.wales@rcahmw.gov.uk](mailto:nmr.wales@rcahmw.gov.uk)).

Ideally the report and images would be sent via a wetransfer.com download link. The majority of our staff are currently working from home due to the Covid-19 restrictions and there may be a delay in the receipt of any posted items.

On dispatching the high-resolution files to the HER/NMR the applicant should confirm this in writing with me directly and at that point I can confirm discharge of the condition.
