NOTES: EXISTING 30 MINUTE SELF CLOSING DOOR TO PROPOSED KITCHEN TO BE REMOVED AND RE-HUNG TO OPEN INTO ROOM (FITTED WITH INTUMESCENT STRIPS AND BRUSHES) 1.

2. TAKE DOWN EXISTING FRAMING AND REINSTATE OPENING BETWEEN LOUNGE AND PROPOSED KITCHEN, FIT WITH BESPOKE BI-FOLD DOORS OPENING INTO LOUNGE & TO SIT FLUSH WITH REAR WALL, BESPOKE TIMBER BI-FOLD DOORS TO MATCH IN MOULDED DETAIL AND HEIGHT TO DEVENDE FUTURE FOR TO LOUNDE FOR AND VEDUCE.

- TO EXISTING ENTRANCE DOORS TO LOUNGE AND KITCHEN.
- EXISTING ORIGINAL TIMBER WINDOW REMOVED. EXISTING STONE CILL AND AIR GRILL AT LOW LEVEL REMOVED AND NEW BESPOKE TIMBER DOORS, TO REFLECT EXISTING TIMBER WINDOW DETAIL FITTED. REMOVE EXISTING STONE STEPS 3.
- EXISTING TIMBER DOOR REMOVED, STONE CILL FROM FRONT BAY FITTED TO SIDE OPENING AND LOWER OPENING INFILLED WITH STONE TO MATCH EXISTING ELEVATION. NEW BESPOKE TIMBER DOORSET TO REFLECT EXISTING TIMBER WINDOW DETAIL.REFER TO PROPOSED ELEVATION DRAWING FOR DETAIL ON BESPOKE GLAZED/TIMBER DOORSET. RE-LOCATE REMOVED STONE STEPS TO NEW OPENING 4.
