T1 Norway Maple, reduce the trunkated stems approx 3 - 4 metres below the original pruning cuts.

T2 Norway Maple on rear boundary, Reduce 3 long lateral branches over the neighbours garden by up to 3 metres and remove the long low branch over garden. Prune branches away from electricity line.

T3 Sycamore growing next to electricity pole and cable. Fell tree as it is too close to the cables and pole.
