T2 Norway Maple on rear boundary, Reduce 3 long lateral branches over the neighbours garden by up to 3 metres and remove the long low branch over garden. Prune branhces away from electricty line.

T3 Sycamore growing next to electricty pole and cable. Fell tree as it is too close to the cables and pole.
