Horse Chesnut Tree (T1) - We originally applied for the removal of a dead branch. However, as the months progressed we noticed that more of the tree has died. When the tree surgeon came to remove the branch, he noticed that the bark was coming off, and that there was fungi and black 'weeping' on the trunk (photographs provided), and has recommended the removal of the tree.
