e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Ash, crown reduce by 3-4 metres in height and spread to reduce shading on front garden, and reduce wind loading on previous pruning points.
T2 - Western Red Cedar, remove lowest limb on North side of stem to reduce shading on front garden.
