# 15 Pinewood Ave, Bispham, Blackpool FY2 0EF

## Forward

The proposal is located at the side and rear of the semi detached property, and consists of single storey side and rear extension, to create a garage / store, utility , ground floor and enlarged kitchen and family room.

The Property benefits from a detached concrete garage , however this is to be removed as part of the development.

The proposal at the side is to be set back 1.050m from the front elevation. Which will provide 6m distance from garage door to pavement. The existing provision at the front is to be maintained. The rear extension is to project 3m from the rear elevation and is in accordance with adopted Supplementary Planning Guidance.

The roof facing the highway and part of the side is to be pitched with tiles following the existing dwelling style. The rear extension is predominantly flat roofed with a feature lantern, to create minimum impact to surrounding properties. There are also several other properties in the locality with flat roofed extensions.

## Materials

External walls to match existing London type brick, the roof is covered in brown Marley Ludlow major tile to the pitched areas which will harmonize with the existing and adjacent property. The new doors and windows are to be white UPVC.

## Flood risk

The proposal is not located in an area designated at risk from flooding. However the applicant have considered the risk and the extension is to be constructed at the same level as the existing dwelling. The floor is solid and sockets are to be positioned minimum of 300mm above floor level.




