On inspection in Autumn 2020 and again in January 2021, arborist Mick Williams from MW Tree Services recommended submitting this planning application for the felling of the following diseased / damaged trees:

T1: Ash: suffering from ash dieback ie blackened leaves, branch dieback and loss of limbs evident, request felling / removal

T2: Ash: ash dieback as T1 above, request felling / removal

T3: Sycamore: significant cavity at base, unstable, request felling / removal
