e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 Western red Cedar - Excessive shading, discolouration throughout canopy, heavily leaning and weighted stems over footpath of garden, growing within/slightly in front of boundary hedge. Fell to ground level.

T2 & T3 Common Lime - A large number of dead branching and epicormic growth throughout both canopies. Crown reduce by 2-3 meters, remove epicormic growth and deadwood, to reduce sail.

T4 Copper Beech - Branches starting to encroach on adjacent road, dense crown with a number of crossing/dead branches. Crown reduce by approximately 2-3 meters, given the size and location of the tree. Remove crossing/dead branches.
