T1 Scots pine. Dismantle to ground level. The tree grows directly through the canopy of a semi mature Beech tree. The tree also has decay at the base of the stem where a wasps nest was located in the past. removing the Scots pine would allow the beech grow in its natural form.  
T2 Willow. Re-pollard just below old pollard points to allow the arborist to bring it into a better shape than previously cut.
