e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore (T1) Reduce height by approx 50% (from current 16m to 8m) due to the close proximity & significant lean of this mature tree towards the applicant's house. Also excessive overshadowing & debris caused by these trees which have little amenity value.
Sycamore (T2) Reduce overall crown by approx 25% due to excessive overshadowing & debris.
Sycamore (T3) Reduce overall crown by approx 25% (as above).
Sycamore (T4) Reduce overall crown by approx 25% (as above)
Silver birch (T5) Reduce overall canopy by approx 50% due to excessive size & debris.
