Leylandii(T1)  
Reduce by 5 Metres to remove issues of excessive shading for property owner and the property behind and to reduce wind sail of tree as concerned about failing and resulting in damage to next door drives and parked vehicles.

Leylandii(T2)  
Reduce by 5metres to keep in line with rest of row of leylandii, to keep screen but again reduce issues of wind sail which has already led to a lower limb failing. This will also reduce light issues for next door, along with concern about tree safety in respect to there property and vehicles
