Yew hedge has been ignored for many years and is now severely overgrown being 20 feet high with little foliage up to 6 feet and long straggly branches no longer resembles a hedge. It is 6 feet at its closest from the house and makes the east side of the garden dark with no sunlight. It is unconnected to any structure or plant. It is unmanageable and we wish to make it into a proper hedge 8 feet high. First year to top the hedge and the following year prune east side maintaining its health.
