The tree is a Western Red Cedar (*Thuja plicata*) located in-between the building at 1 Fountain Street, Nailsworth and the properties rear car park. Location plans have been submitted. Applying to reduce the size of the tree by whilst maintaining the conical shape due to excessive shading and damage being caused to the building both directly and indirectly. Removal of all timber and responsible disposal of wood chip for recycling as biomass fuel.
