e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Sweet chestnut - Located in the rear garden. Mature specimen approximately 18 metres in height with a lateral spread of 10 metres. The tree is leaning and is top heavy due to previous pruning which is bias to the outbuilding. Also the root plate has taken on a steep bank. It has previously had a large branch fail approximately a month ago.

The proposed work - To dismantle down to ground level and replant.

T2 - cypress - located in the rear garden in the right hand corner. Mature specimen approximately 17 metres in height with a lateral spread of 6 metres.

The proposed work - To reduce in height by approximately 8 metres to reduce the wind sail.
