White Beam - (T1) - Crown reduction to leave 2/3rds of crown. Currently encroaching on road.
Willow (T2) - Remove. Poor quality, self-set tree growing next to wall. Tree surgeon advises in danger of damaging wall and also affecting T1.
Alder (T3) - Remove. Growing too near to house and too big for a small garden.
Pear (T4) - Remove - positioned too near to house. Replace with fruit tree nearer to boundary.
The garden has been poorly maintained by the previous owners. In making this application we have taken the advice of a qualified tree surgeon (Matthew Allen - Tree Surgeon & Forestry Contractor).
