e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Eucalyptus - Crown Reduction - Reducing the height and spread of the tree by up to 3 metres to previous pruning points.  
Bay - Crown Reduction - Reducing the height and spread of the tree by up to 2 metres.  
The trees are overgrown and overshadowing so works are required for routine maintenance.
