- Completed application form (find attached)
- Fee of £465
- Site plan showing the location of the proposed signage
- Details of the proposed signage either to scale or with annotated dimensions including height, width and thickness. Please also include height from the ground and details of any fixing/structure it will attached to.
- Proposed material and any illumination

The key consideration will be siting and design and any impact on highway safety, we will consult with the Highways Authority as part of the application.
